APPLICATIONS

Please complete all fields on your Business Expo Application, as applicable. An Indemnification Agreement must be included with your Business Expo application. Incomplete applications will not be accepted.

FEES

Because businesses are not allowed to sell items at the Business Expo, the market will not charge a booth fee to Business Expo participants.

STALLS

Stall size is approximately 11 ft. wide x 12 ft. deep. This will allow for a 10'x10' canopy with a small margin for logistics. Vendors/businesses must keep their tables, signs and products within the boundaries of their assigned stall. It is imperative that we keep the walkway clear for our customers' safety and ease. Please be considerate to your neighbors as stalls are sometimes butted up against each other. Vendors and businesses are expected to be cooperative and civil. Issues should be brought to the Market Manager for resolution.

Please Note: Canopies, tables and chairs will NOT be provided.

MARKET DAY EXPECTATIONS

IF YOU NEED TO CANCEL - please email the Market Manager at farmers_market@northfieldmi.gov or text/call (734) 881-0073.

Market hours are from 10:00am-2:00pm. Please expect to remain for the entirety of the market day. The market will run regardless of weather, with the exception of severe weather such as lightening/thunderstorms, hail or threat of a tornado.

Set up begins at **8:30am**. Please claim your stall in person or by phone by **9:30am**. Vendors must be completely set up by **10:00am sharp!** The market closes at 2:00pm, **packing up early is not permitted**. Closing should be completed by **3:00pm**.

A Business Owner arriving after the time listed above may be turned away. It is very disruptive to have a Business Owner setting up after the market opens.

BUSINESS OWNER CONDUCT

Business Owners at the Market are expected to behave in a professional and courteous manner. While participating in the market, vendors and business owners shall civilly serve any person (customer or vendor) without regard to race, color, religion, national origin, gender, sexual preference or identity, age or disability. Violation of this agreement will require review by the Market Manager or Township Administration and may result in the termination of Business Owner agreements and/or permanent dismissal.

Business Owners shall not engage in behavior subversive to the Market or the effective management thereof. Such behavior may include but is not limited to:

- negative communication about the market, vendors, other business owners, or the market management to market patrons or other vendors (spoken, written or online)
- misrepresentation of products
- inappropriate conduct

NO SMOKING

Smoking and vaping by the vendors, business owners and customers is not permitted.
